- 3119 Chairman's Opening Remarks The Chairman welcomed everyone to the meeting.
- 3120 <u>Law & Order</u> PC Ollie Turner had sent his apologies for the meeting but had provided the following update. Police Officers had patrolled the area outside Kirkella St. Andrews Community Primary School mainly in the mornings as this seems to be the time when most issues of non-compliance and dangerous parking occurs. Despite trying to educate the offenders, less than favourable comments were received by some of the parents. The majority of parents are taking note of the zig zags and parking restrictions. To date, no Parking Enforcement Officers have been seen in the area.

- Minutes of the Parish Council Meeting 9th October 2023 Minute 3108 (3094/3084) to read The Clerk confirmed that the speed survey on West Ella Road carried out in June 2022 was positioned on the lamp post requested by the Parish Council and the speed of traffic was found to be acceptable. The minutes of the Parish Council Meeting held on Monday 9th October 2023 were then accepted as a true record of what took place and duly signed by the Chairman.
- 3122 Matters Arising from the Minutes

Minute 3102 - A site meeting had taken place at the proposed location for the Mill Lane seat. The E.R.Y.C. Housing Officer had attended along with residents, the Chairman and Clerk. An exact site had been agreed, E.R.Y.C. to arrange for a concrete base or paving slabs to be installed. The wording for the plaque is still being considered, sufficient donations had been received from Mill Lane Neighbourhood Watch to purchase a 'Stanford' style seat from Glasdon UK. It was agreed the Parish Council will pay the installation costs.

- a) <u>Standards Committee Vacancies for Two Parish Council Representatives</u> Two vacancies exist for Parish Council representatives on East Riding of Yorkshire Council's Standards Committee - no volunteers from the Parish Council at present.
- b) Annual Snapshot of Rough Sleepers in the East Riding of Yorkshire Council 2023 A survey is being carried out by the E.R.Y.C. to assess the scale of rough sleeping within the East Riding of Yorkshire. Councillors had not seen anyone sleeping rough in the parish of Kirk Ella and West Ella on the evening of Thursday 9th November into the morning of Friday 10th November.
- c) Email from Resident re. Road Safety Church Lane Kirk Ella Concerns had been expressed about the speed of some vehicles travelling along Church Lane. The bend in the road creates a blind spot which is of concern as the majority of the lane has pavement only on one side of the road and in some parts this is very narrow. The Clerk was asked to contact E.R.Y.C. to request a speed survey be carried out after obtaining the preferred location from the resident. The Chairman suggested also contacting Community Speed Watch for advice.
- d) Email from Resident re. Bollard on Cycle Path between West Ella Road and South Ella Way The wooden bollard situated in the middle of the cycle path/walk way near the end of West Ella Way is dangerous and requires either painting white or reflector strips attaching. Clerk to pass on to Cllr. Saribal to take up with E.R.Y.C.

- e) Email re. Haltemprice Skate Park The Clerk read out an email from Mr. C. Lawson, Chairman of the Haltemprice Skate Park Association, the contents of which were noted by members present. It was agreed unanimously to make a contribution of £750 for this financial year.
- f) Put forward a Topic for Scrutiny E.R.Y.C. No suggestions at present.
- g) Adoption of Highways (Phase 1) West Hill The Clerk had been contacted by Beal Homes Site Manager advising that Phase 1 adoption of the roads is currently being considered. E.R.Y.C. will not adopt the two brick walls at the entrance to the site, one of which houses the Parish Council information board and notice board. Parish Council to consider either taking over ownership of the walls or removing the boards and re-siting them elsewhere. Clerk to contact E.R.Y.C. Highways to understand why they will not adopt the walls and what will happen to them if the Parish Council does not take over ownership.

 - 23/02866//TPO KIRK ELLA 1980 REF 209 W1 Fell 15 No. Sycamore trees (T1, T2, T3, T4, T5, T6, T7, T8, T9, T10, T11, T12, T13, T15, T17, T18, T20) for various reasons (see application form) Prune 4 No. Sycamore trees (T14, T16, T19, T21) for various reasons (see application form); Crown lift 1 No. Lime tree (T21) to 6m; Crown lift 1 No. Sycamore tree (T22) to 6m - 61 Elveley Drive, West Ella - We recommend the ERYC Tree Officer carries out a site visit to determine: That all the work proposed to the mature TPOd trees is required and will not affect the protected bird population. That all the trees proposed to be felled are worthy of being felled and a Tree Officer report is made before the application in its current form is accepted. To re-plant new trees, this may require some of the stumps of the felled trees to be removed as many of the trees to be felled are Sycamores which have a habit of sprouting and re-growing from the stumps. The suggested trees to be replaced are those which are good for wildlife. In recent years a number of applications on this woodland have been passed with Caveats that trees were to be replaced over a period of time, in a number of cases we do not believe this has been carried out. To conclude we RECOMMEND REFUSAL until we have seen a Tree Officers report and any changes recommended by him are incorporated.
 - 23/02977/TPO TPO KIRK ELLA 1984 REF 216 G1 Fell 1 No. Sycamore tree (T1) and Fell 1 No. Ash tree (T2) as the trees are affecting the buildings foundation levels Ancora 32 Church Lane, Kirk Ella A very detailed set of reports in the application which appears to identify the cause of the problem to be the roots from the Ash (Fraxinus spp) only. This would lead to the conclusion that only the Ash tree needs to be felled. We feel that further investigation by the ERYC Tree expert is necessary before this application is granted.
 - 23/01818/PLF Erection of two storey extension to side with associated internal and external alterations (Re-submission of planning reference 19/03080/PLF) - 6 Grundale, Kirk Ella - No objections.

3126 Highways

- a) Street Lighting Cllr. Bailey informed members of the issues with the old painted street lamps from West Green to Elveley Drive, West Ella. They need to be looked at to ensure the light units are the brightest that can be fitted plus can E.R.Y.C. determine whether the lights are directed as best they can be to throw the light over to the footpath across the road. There is one particular dark spot along the footpath by the small wood opposite the boundary between numbers 7 and 9 Riplingham Road where a new lamp post is needed so that the footpath can be adequately lit. Clerk to discuss with E.R.Y.C.
