<u>Minute 3096b</u> - Cllr. G. McMaster briefed members on a conversation he'd had with Willerby Parish Council about funding for the Haltemprice Skate Park. The Clerk was asked to write to the Chairman of the Haltemprice Skate Park requesting an up-to-date copy of the Skate Park accounts and confirmation that they are now registered with the Charity Commission. On receipt of this information, a meeting will be arranged with all three Parish Councils to discuss funding.

Minute 3096c - E.R.Y.C. had acknowledged receipt of the Parish Council response to the Community Governance Review Draft Recommendations and advised it will now be considered by the Member Working Group when it next meets. The final recommendations report will then be considered by full Council at its meeting on 15th November 2023.

3111 Planning

- a) Planning Applications 9th October 2023
 - 23/02652/PLF Erection of single storey extension to side and rear 7 Ashworth Drive, Kirk Ella - No objections.
 - 23/02455/PLF Erection of single storey extension to rear 51 Fairfield Avenue, Kirk Ella **No objections.**
 - 23/02724/TPO T1 Dismantle mature Ash tree due to Ash Dieback; T2 4 metre lateral reduction of mature Beech tree which canopy extends over private driveway between properties, only the lower canopy would require a 4 metre reduction, as the canopy raises it would be feathered back to 0 Southwood 23 Church Lane, Kirk Ella The sketched plan is inadequate. We are happy for the ERYC Tree Officer to deal with this application.
 - 23/02488/PLF Conversion of existing detached garage into additional living accommodation (self-contained annex) including erection of single storey extension to rear and glazed panel and door with pitched roof over to side 5 Allanhall Way, Kirk Ella We have no objection to the garage conversion. We have concerns about the removal of the common Ash tree and the possible interference with the roots of the Copper Beech tree. We would like the ERYC Tree Officer to monitor this. (The Clerk explained that this 'Householder Application', if approved, will have a condition attached saying the detached garage cannot be sold off separately. It is strictly associated with the dwelling).
- b) Planning Decisions 13th September to 5th October 2023
 - Erection of first floor extension to side 12 Laxton Garth, Kirk Ella GRANTED (PC response No comment).
 - Erection of two storey and single storey extensions to rear 139 West Ella Road, Kirk Ella - GRANTED (PC response No comment).

3113 Events

- a) Christmas 2023 Cllr. B. Weeks gave an update on the plans so far for Xmas 2023. It is hoped that additional lighting will be installed on the trees in St Andrews Churchyard. Cllr. G. McMaster gladly confirmed that Fin Clark, GBR U21 Compound Archer will be switching on the Christmas tree lights this year.
- b) Remembrance Day Service Sunday 12th November 2023/Purchase of Poppy Wreaths Cllrs. B. Weeks, Bailey and Richardson to attend the service on 12th November at 11.00am. It was agreed to order two poppy wreaths and six poppy crosses.

3114 Environment

- a) <u>Salt Bin Replenishment</u> Cllr. N. McMaster was thanked for carrying out a survey of the Parish Council salt bins and Cllr. Richardson was thanked for clearing rubbish out of some of the bins. The survey highlighted bulging of a couple of bins, which require drilling and refilling. It was agreed to ask Mr. Capraro if he can carry out the work required.
- b) Tree/Drains Elms Drive Defer to future meeting.
- c) West Ella Way Road/Pavement Resurfacing It was reported that over-use of the roads and pavements has caused damage to the surface. Concrete slabs are damaged with holes present, pavements are covered in moss and are very uneven. Cllrs. G and N McMaster to inspect and report back their findings. Cllr. B. Weeks would like the matter to be dealt with by the three Ward Councillors. Cllr. G. McMaster to progress this.
