- 2932 <u>Chairman Opening Remarks</u> The Chairman thanked Cllr. It was confirmed that the Kirk Ella village sign is now in place on the B1232 near the Waitrose roundabout.
- 2933 <u>Law & Order</u> Members were in receipt of the latest Parish/Town news release and crime statistics for the period 01/06 05/07. The Police had reported continued problems on King George V Playing Field. Burglary, garage theft and shop theft is currently a problem in the Haltemprice area. The Clerk was asked to invite the Humberside Police and Crime Commissioner Mr. Evison, to a future Parish Council to discuss local crime issues.

#### Planning Decisions 8<sup>th</sup> June to 6<sup>th</sup> July 2022

- Erection of two storey extension with balcony to rear 27 Laxton Garth, Kirk Ella GRANTED
- Erection of two storey extension to side following demolition of existing conservatory, and construction of new entrance doorway with canopy to front – Holly Cottage Godmans Lane, Kirk Ella – GRANTED
- Erection of single storey extension to side and rear following demolition of existing conservatory and detached garage – 7 Kerry Drive, Kirk Ella - GRANTED
- Erection of a two storey and single storey extension to rear and detached single storey outbuilding to rear, and alterations to roof of existing single storey rear projection – Kirkfield House 1 Old Annandale Road, Kirk Ella – GRANTED
- Erection of two storey extension to rear, increase in roof height, construction of dormer to front and addition of render to rear – 73 Wolfreton Garth, Kirk Ella – GRANTED
- Erection of single storey extension to side and single storey extension to rear following demolition of conservatory – Greenacres 25 Great Gutter Lane West – GRANTED
- Erection of a single storey timber framed garden room and erection of a single storey glass and aluminium green house to rear – 1 Kirkby Meadows, Kirk Ella – GRANTED
- TPO Pine Meadows 1970 (ref 204) Crown lift 1 no. cedar (T9) Crown lift of 5.5/6m to make level with nearby roofs and rebalance the tree. Large branches are close to property 23 and 25 Allanhall way and a nearby telephone line with risk of causing damage, works will improve line of tree, sky view and help to maintain the tree – 23 Allanhall Way, Kirk Ella - GRANTED

#### 2940 Environment

- a) Untidy Land West Ella Road, Kirk Ella Clerk to contact Electricity company and request they tidy up their piece of land at the front. Clerk to ask E.R.Y.C. to contact the owner of the land at the side and rear and request a tidy up. A meeting had taken place on site previously to investigate the tree and the damage to the railings at the front, E.R.Y.C. did not have any concerns about either.
- b) <u>Sewage Flooding</u> Residents are reminded to report any flooding concerns/issues to Yorkshire Water.
- C) Oak Tree on former Wolfreton Upper School Site Cllr. Horton updated members on his conversation with the E.R.Y.C. Tree Officer, advising that although the tree is currently very unbalanced due to the branch falling off, the Tree Officer feels the tree could be saved to some level. The possibility of fencing off the tree for safety of residents etc. was also discussed. Cllr. Weeks suggested reclaiming some of the wood which had broken off to make a commemorative bench or similar. Cllr. Horton to arrange for Cllrs. Bailey and E. Robinson to visit the site to inspect the tree.
- 2941 <u>Highways</u> The lamp posts on School Lane need cleaning/repainting or replacing, Clerk to check E.R.Y.C.'s list of works. Road surfaces on The Fairway and Elms Drive are by far the worst in the area and need inspecting by E.R.Y.C. Highways. The resurfacing works on South Ella Way is well underway despite a request for it to be delayed until the new housing development is complete. It was agreed to move Highways further up the agenda from the September meeting.
