- 2887 <u>Chairman's Opening Remarks</u> The Annual Report is now complete and with the printer, thanks were given to the Clerk for finalising the 'Meet your Councillors' page. Permission had been received from Beal Homes to erect a Parish Council information board and notice board on the entrance wall on the West Hill development. Warcup Construction Ltd had collected the Kirk Ella village sign from Cllr. D. Robinson and will construct a post for the sign then erect it on the B1232 near the West Hill development. It is hoped that the tree in memory of Captain Sir Tom Moore will be planted soon. Cllr. E. Robinson agreed to store the Parish Council dog stencil and spray paint for residents to use.
- 2888 <u>Law & Order</u> Members received the Kirk Ella and West Ella statistics 14/02/22 10/03/22 showing one criminal damage to a fence on Valley Drive, two attempted burglaries one on Valley Drive and one on Annandale Road, investigations are ongoing.
 - a) <u>Humberside Police & Crime Commissioner Community Payback</u> Last year the Government relaunched the Community Payback scheme (previously known as community service), where offenders work on projects to pay back the community for their crimes. The unpaid work is supervised and is usually tough and physical so it acts as a visible punishment. Two areas to be submitted for consideration 1) King George Playing Field and 2) Bridleway from Riplingham Road to Great Gutter Lane West.
- Minutes of the Parish Council Meeting 14th February 2022 Minute 2874 Remove 'Cllr. E. Robinson advised that Kirk Ella Grapevine is considering using the same system' and replace with 'Cllr. E. Robinson advised the future of Kirk Ella Grapevine is currently under consideration'. - c) <u>Finance Report</u> Members received and approved the latest finance report 14th March 2022 which included HSBC Bank Charges of £10.00.
- d) East Riding of Yorkshire Council The Queen's Platinum Jubilee Community Fund The Parish Council's application for £500 towards the cost of two display boards for the new housing development on South Ella Way had been successful. Cllr. Weeks to recreate the timeline for the history board showing who has reigned through the life of the 350 year old Oak tree.

2892 <u>Correspondence</u>

- a) Parish Council Vacancy The Chairman had received a letter of resignation from Cllr. Nicola McMaster. E.R.Y.C. had been notified of the vacancy and it had been advertised accordingly. The Clerk had so far received one letter of interest from a resident.
- b) Haltemprice Skate Park The Clerk read out a letter received from the Chairman of Haltemprice Skate Park about funding for the Skate Park. A copy of the annual expenditure was circulated for information and it was advised that the Skate Park insurance includes public liability cover of £5m. It was agreed that members of the Parish Council will visit the Skate Park at random times to gauge Kirk Ella and West Ella footfall. The Clerk was asked to reply with the following: 1) Has the Skate Park Committee considered introducing a fee to enter the park or an annual fee? 2) Request a copy of the application which was submitted to the Lottery Commission for the initial funding 3) Has E.R.Y.C. been asked to adopt the Skate Park? If so what was the outcome. If not, why not? 4) Actual footfall for a 12 month period. It was agreed further discussion is required at the April Parish Council Meeting, with a view to making a decision about funding.
- c) Town and Parish Council Network Meetings 16 & 17 March The first Town and Parish Council Network Meetings will take place on 16th March and 17th March. Clerk to obtain and circulate notes from the sessions.
- d) East Riding Community Governance Review Councils such as the East Riding of Yorkshire Council have the power to carry out community governance reviews in their area. Community governance reviews consider whether parish councils in the area should be created, dissolved or altered (this can be in relation to the boundaries of a parish, the number of councillors on a parish or the name of the parish). After discussion, it was agreed to put forward for review the location of Tudor Court, Willerby, there appears to be an anomaly with this location, which undeniably should be in Kirk Ella

- e) <u>Sustainable Travel in Your Parish</u> As part of E.R.Y.C.'s commitment to encourage sustainable travel in the region, Parish Councils are being offered projects aimed at encouraging cycling and walking within the local area, projects such as cycling workshops on basic mechanics, cycle libraries to provide bikes to those wishing to use them on a loan basis etc. Clerk to attach to the agenda for discussion at the next meeting.
- f) <u>East Riding Design Guide Consultation</u> E.R.Y.C. are inviting residents across the authority to share their thoughts about where they live as part of a consultation which will go towards creating new design guidance for future planning developments. 2893 Planning

a) Planning Applications 9th February to 8th March 2022

There has been a lot of disquiet about the house on West Ella Road which applied to build a swimming pool in the garden and is now a bungalow.

- Erection of single storey and two storey extension to rear Birch Lodge, 17 West Green, West Ella - Noted.
- Erection of single storey extension to rear following demolition of existing extension and construction of roof light in existing roof at front to create additional accommodation 2 Egginton Close, Kirk Ella Noted.
- Erection of single storey extension to rear 18 Laxton Garth, Kirk Ella Noted.
- Widening of existing vehicular access, erection of boundary wall to front and installation of piers and gate to front 37 Elveley Drive, West Ella The existing wall, hedge and metal gate shown in the planning application is in keeping with the other property boundaries in the area. The proposed new higher wall and covered-in gate are not in keeping with the open aspect which currently exists down Elveley Drive and other properties in the area. E.R.Y.C. Planning Department should not be encouraging this type of boundary, leading to isolationism of properties. On this basis we strongly object to the planning application being granted.
- Erection of two storey extension to front, single storey extension to rear and extension to existing dormer window to side – 25 The Lunds, Kirk Ella – Noted.
- TPO MD 519 (REF 227) G2 Crown reduce 1 no. Beech tree (T1) by 3 metres due to pieces falling off on breezy days whilst the applicant's grandchildren have been playing in garden – 1 West Green, West Ella – Noted.
- KIRK ELLA CONSERVATION AREA Remove 1 no. Leylandii hedge as it has not been regularly maintained, is overhanging the road and pavement, and appears to have been hard reduced previously and has bare stems adjacent the boundary, any reduction work would need to go back to the bare stem, which is unlikely to recover and would be unsightly – 12 Packman Lane, Kirk Ella – Recommend approval.
- Erection of garage extension and erection of brick pillar and fencing above existing low wall to side – 1 The Paddocks, Kirk Ella – Recommend approval.
- Erection of two storey extension to rear, erection of first floor extension to side, construction of flat roof dormers to front, side and rear, erection of porch to front, addition of 10 rooflights and alteration to roof over existing single storey extension to rear 60 West Ella Road, Kirk Ella Noted.
- Erection of two storey extension to rear and alteration of flat roof to pitch roof, single storey extension to side and rear following removal of canopy, erection of a single storey extension to side following removal of existing garage and construction of boundary wall and gates – 139 West Ella Road, Kirk Ella – Noted.
