- a) Co-option to fill two vacant positions on the Parish Council A total of seven candidates had been duly elected uncontested out of the nine vacancies. Acceptance of Office forms had been completed. The remaining two vacancies can be filled by co-option within 35 working days of the polling day. The co-option of Mr. John Bailey (former Councillor) was agreed unanimously. It should be noted that East Riding Council employees can be members of a parish or town council; it is only East Riding of Yorkshire Council that they cannot stand for as it is their employer.
- b) The Pension Regulator Automatic Enrolment Duties: Acknowledgement of redeclaration of compliance Kirk Ella & West Ella Parish Council had completed a redeclaration of compliance with The Pensions Regulator under the Pensions Act 2008. Date of re-declaration 03/05/2023, date of re-enrolment 28/04/2023.

c) Email from E.R.Y.C. Daffodil Bulbs 2023 - The free supply of daffodil bulbs from E.R.Y.C. has come to an end. It is recommended that any future planting of daffodil bulbs or any other planting to improve the appearance of the area must be discussed with E.R.Y.C. Area Grounds Supervisor. This is to ensure E.R.Y.C. knows what is purchased, where it goes, to ensure the safety of the person planting and to ensure they don't end up in areas unsuitable for planting or cause maintenance issues.

3057	<u>Events</u> - It was agreed a Working Group consisting of Cllrs. S. Horton, N. McMaster, B. Weeks and R. Weeks meet with Reverend Ash Carter and the Landlord of The Wheatsheaf to discuss plans for Christmas 2023. Cllr. G. McMaster to liaise with E.R.Y.C. about making the process of road closures easier for community groups.
3058	<u>Update on Environmental Issues</u> - It was agreed to pass the problem of the untidy former electric sub-station land on West Ella Road Kirk Ella to E.R.Y.C. Planning Enforcement. It was reported that the verge area near number 2 Pine Meadows had been cleared. The blue and white lamp posts on Wolfreton Garth and School Lane still need cleaning and repainting; this had been reported to E.R.Y.C. so no further action is required at present. Members were asked to monitor the two rare Indian Bean trees on Wolfreton Garth, one half way down on the right and the other opposite the entrance to Wolfreton Garth, on Beverley Road, near the corner with Church Lane. Clerk to contact E.R.Y.C. Tree Officer requesting an inspection.
