- b) <u>Update on Parish Council Elections 4th May 2023</u> Seven Councillors have been elected uncontested. The Parish Council now has 35 working days to co-opt to fill the two vacant positions.
- c) <u>Kirk Ella & West Ella Heritage Trail</u> Cllr. Horton had been approached by a resident who would like to produce an update on the Heritage Trail booklet. Copyright of the current booklet is owned by the Author, Mrs. Margaret Raymond, who is happy for the resident to write a completely new booklet. Clerk to invite resident to speak at the June Parish Council Meeting. Clerk to investigate possible funding opportunities with E.R.Y.C.
- d) <u>East Riding Local Plan Update Submission</u> It was reported that East Riding of Yorkshire Council submitted the East Riding Local Plan Update on Friday, 31 March 2023 to the Planning Inspectorate for an Examination in Public.

The design work is not in-keeping with the 1930's style property. We have significant concerns about the size of the dormer in relation to the size of the existing house. We would like this to be referred to the Western Area Planning Committee.

- 3041 <u>Environment</u> Cllr. Richardson expressed his concern about the number of grass verges damaged due to vehicle parking. Members were in agreement with the idea of providing a blue plaque as an acknowledgement to Stan and Margaret Raymond for their service to the Parish Council.
