- 3003 <u>Chairman's Opening Remarks</u> The Chairman thanked those members of the Parish Council who were involved with the production of the Annual Report. Thanks were given to the members that attended the funeral of Cllr. Doreen Kaye.
- 3004 <u>Law & Order</u> PC Oliver Turner discussed crime during the month of January 2023. Burglary currently a concern, generally occurring between the hours of 6pm and midnight. The police.co.uk website is now back up and running after some technical difficulties. The Police are working closely with Wolfreton School tackling anti-social behaviour in the area, particularly in Willerby Square. Residents are urged to keep doors and windows locked even when inside the property. Extra security measures should be considered, flood lights, cameras etc.

Minute 2985 - Help with the 2<sup>nd</sup> Kirkella Scout and Guide Hut is ongoing.

Minute 2991 (2977) - A meeting had taken place with the three Haltemprice Parish Councils, the purpose being to discuss a future joint approach with funding. It was clear that all three Parish Councils would like more information on the work of the Skate Park Committee and membership and a better understanding of what funds are required to run the Skate Park on a yearly basis and what the reserve account funds are for. The possibility of a three year financial agreement was discussed. It had been agreed to hold a further meeting after the May elections with two representatives from each Parish Council plus representatives from the Skate Park Committee. Posters inviting volunteers and donations had been displayed on the notice boards in the three parishes and messages placed on Parish Council websites and social media pages. Cllr. Hardy had been interviewed on Radio Humberside.

Minute 2991 (2977) - Cllr. Horton had reported the overgrown trees on Allanhall Way snicket to E.R.Y.C.

Minute 2994(a) - The Chairman invited West Ella resident Gill Locking to speak about the installation of the telegraph poles by MS3. E.R.Y.C. is not responsible for this work, it is a Government initiative. The erection of telegraph poles is known as "permitted development" and full planning permission is not required. The Local Authority can comment on the location of such proposals but cannot object to the installation as a matter of principle. A meeting is due to take place on Friday 17<sup>th</sup> February with MS3, Gill Locking and Trevor Green, Chairman of the West Ella Preservation Society, to try and understand why many areas have underground cables and the West Ella Conservation area has telegraph poles. It was reported that KCOM would not agree to MS3 sharing their telegraph poles. The Chairman thanked Gill for her hard work on this issue and asked that the Parish Council is kept informed.

<u>Minute 2994(c)</u> - The damage to the grass verges on Valley Drive had been reported to the E.R.Y.C. Streetscene Enforcement.

Application 22/03975/PLF - Erection of petrol filling station with shop, electric vehicle charging hub and drive-thru coffee shop with associated access, parking, servicing and landscaping areas - Land West Of Riplingham Road Roundabout, West Ella - After a lengthy discussion it was clear that members have a number of serious concerns regarding this application and the response to E.R.Y.C. will include: Reference to the Local Plan, Drainage and Water Pollution, Litter, Traffic and Road Safety, Loss of Amenity, Light and Noise Pollution, and the development being inappropriate and not needed due to sufficient facilities already in the area. Residents were reminded they must write in to E.R.Y.C. with their own comments.
