2448 Apologies for Absence - Cllr. R. Skinner.

2449 Chairman's Opening Remarks - The Chairman thanked all the Councillors who had worked hard at the coffee morning on 20th November. Cllr. D. Robinson was thanked for his magnificent photograph display; the sum of £91.55 had been raised. Grateful thanks were given to Cllr. D. Kaye and the Clerk for organising the Christmas lights switch on event, the Chairman was delighted to see so many residents in attendance. Thank you to Cllr. E. Robinson for her hard work as Chairman of the Haltemprice Flood Group, the hard work of this group has contributed immensely to the work taking place on Beverley Road Anlaby. Preparation of the annual report will begin shortly; items for possible inclusion should be passed to the Publicity Officer, Cllr. M. Raymond, for consideration.

2450 Law & Order - It is hoped that Police Sgt. Helen McGill will attend a future Parish Council meeting to introduce herself to members. Residents should be aware that some attempted burglaries had taken place in the parish. Cllr. E. Robinson to provide the Clerk with some wording for displaying on the notice boards and website, warning residents of possible criminal activity in the area and the need to be extra vigilant. Members are very concerned at the lack of police attendance at the Parish Council meetings.

2451 Minutes of the previous Parish Council Meeting - The minutes of the meeting held on Monday 13th November 2017 were accepted as a true and faithful record of what took place, and were duly signed by the Chairman.

2452 Matters Arising from Minutes

Minute 2439 (2426) - Willerby Post Office will re-open in Wishes from early February 2018.

Clerk to arrange site meeting with E.R.Y.C. Highways to agree sites for the two notice boards. Cllr. E. Robinson suggested looking at locating one opposite the shops on South Ella Way, same side as The Beech Tree.

E.R.Y.C. price to supply and install a litter bin on King George Playing Field is £377.16. There is still litter around the proposed site. Members sanctioned the purchase of a bin. Clerk to seek approval from E.R.Y.C.

The E.R.Y.C. Planning Enforcement Officer (Stephen Walker) has confirmed that the owner of 246 West Ella Road has given assurances that the pig sty will be restored following completion of works at the property.

Minute 2439 (2431) - The lanes on the A164/B1232 roundabout at Willerby have been re-marked.

Minute 2441 - E.R.Y.C. confirmed that the Town and Parish Council Name Bank for Kirk Ella & West Ella is now in use for developers with immediate effect. The Parish Council may submit more suggestions at any time.

E.R.Y.C. had confirmed that the topic suggested by the Parish Council for scrutiny "*Pressure on key services as a result of expansion due to development, i.e. doctor's surgeries, school places etc.*" will be put forward to the relevant overview and scrutiny committee for consideration at their workshop in January.

Cllr. E. Robinson reported there had been a similar case in Swanland whereby KCOM had installed poles and overhead wires for the lightstream service, which resulted in KCOM being asked to remove them. This matter is being dealt with by Ward Councillor Shaun Horton.

Minute 2442 - Cllr. D. Robinson had contacted G4 for a price to produce a Heritage Trail map, style and framing to be the same as the one located at Willerby Square. Clerk to seek approval from E.R.Y.C. Highways to install a board at the end of Riplingham Road/Elveley Drive. It was agreed to send a letter of thanks to the resident who had very kindly organised the tidying up and planting around the Elveley Drive signs at the Riplingham Road end.

The Clerk circulated a photograph of the seat in Swanland which Cllr. J. Bailey felt would be suitable for King George Playing Field. In 2016, Swanland Parish Council purchased the seat from David Ogilvie Engineering, at a cost of £544.00 and £46.00 for a plaque, excluding VAT.

Minute 2444 - Work on the proposed new roundabout at the end of Riplingham Road/A164 is due to commence April 2019.

- b) Finance Report - The RFO provided members with a summary of the two bank accounts held by the Parish Council.

Cllr. M. Jackson joined the meeting at this point.

- c) Parish and Town Council Precepts and Confirmation of 2018/19 Tax Base - The recommended council tax base for 2018/19 was approved by Cabinet at its meeting held on 12th December. The final 2018/19 tax base for Kirk Ella and West Ella Parish Council is 2,558.2 Band D equivalent properties. The precept divided by the tax base determines the amount of council tax attributable to the town/parish council on a Band D bill. Members were asked to consider the proposed budget for the year ended 31st March 2019, following the budget setting meeting in January. After discussion, a proposal was made by Cllr. S. Raymond to request a precept of £30,500 for the year ended 31st March 2019. Cllr. M. Jackson seconded this proposal. All members were in favour. The rise in precept includes funds to refurbish the West Ella War Memorial.

Email from Willerby Parish Council re. Street Lighting - Willerby Parish Council has been looking into the charges for street lighting on the roads where the Parish Council actually own the street lights and are investigating whether those residents are paying twice for their lighting and is welcoming comments from other Parish Councils. The Parish Council read with interest the reply from E.R.Y.C. and accepted the explanation.

Letter from E.R.Y.C. re. Use of Kirk Ella School for Parish Council Meetings - With effect from 1st April 2018, E.R.Y.C. will no longer pay the rent for the Parish Council to use the school premises for the monthly meetings free of charge. The rental charge for 2016/17 paid by E.R.Y.C. to the school was £262.50 and it is anticipated therefore that a similar amount will be required for the forthcoming year. The letter outlined options available to the Parish Council with regard to future room use. After discussion it was agreed the Clerk liaise with the school direct with a view to continue using the school.

Chairman's Awards 2018 - East Riding of Yorkshire Council presents the Chairman's Awards annually to individuals companies and organisations within the East Riding of Yorkshire in recognition of their achievements towards enhancing the well-being of the area in which they work and live. After discussion, it was agreed to nominate Cllr. D. Robinson for a Chairman's Community Award for his excellent work with many projects such as the information boards, way markers, village signs and more.

2455 Environmental/Events

Local Cycling and Walking Infrastructure Plans – Kirk Ella & West Ella - Comments are required by 12th January 2018 on the second stage of the consultation on the Local Cycling and Walking Infrastructure Plans for Kirk Ella and West Ella.

Environmental Issues within the parish - Cllr. E. Robinson had cut back some of the overgrowth near the golf course on West Ella Road. E.R.Y.C. had also cut some back but left the cuttings on the verge. Cllr. E. Robinson to report to E.R.Y.C. for collection. A complaint had been made to E.R.Y.C. about the debris from the two pine trees in the roundabout outside numbers 65 and 67 West Ella Way; this has still not been swept. Some dead branches need removing from the sycamore tree on the roundabout, this has been reported to E.R.Y.C. Cigarette ends are still present in the grass verges outside The Rowans, Cllr. E. Robinson had spoken to the manager who advised it would be passed on to the Estate Manager to deal with. It was agreed that as the problem has been going on for so long, the Clerk write to the Enforcement Officer at E.R.Y.C. requesting a letter be sent to The Rowans about their staff littering the verges. There is still no dog fouling penalty stickers on the lamp posts on Kerry Drive. Such matters can be reported to E.R.Y.C. by residents, on 01482 393939.

West Ella War Memorial - Cllr. D. Robinson reminded members that three quotations are required to qualify for a grant. A site meeting had been arranged with a third Stonemason to discuss work required and the provision of a quote.
