Cllrs. S. Horton and E. Robinson to meet on-site to identify what work is required.

At the March meeting, the Clerk was asked to inform Mrs. Jean Harne that Willerby Parish Council had met with Officers at Kirk Ella Police Box and this may be something she would benefit from in order to enable her to maintain a good Neighbourhood Watch system. It should be noted that Jean Harne has attended every meeting at the Police Station that has been offered to local Neighbourhood Watch Groups and will continue to do so.

- b) Annual Accounts for Year Ending 31st March 2018 The annual accounts were presented to members for approval. The Clerk expressed her appreciation to Mr. Trevor Green who had very kindly assisted with the completion of the annual accounts and audit paperwork.
- c) VAT Claim 2017-18 A VAT claim had been made for the sum of £1948.25 for the period 01/03/17 31/03/18.
- d) Completion of Internal Audit The Clerk read out a letter from Mr. G. Lawson, Internal Auditor received on completion of the internal audit of the Council's books for the year ended 31st March 2018. Mr. Lawson asked that it be recorded in the minutes, the efficient way in which the accounts were presented to him. The professional commitment and due diligence applied to the recording of the accounts reflect the high standards of the financial officer, Mrs. A. Pickering. The parishioners of Kirk Ella & West Ella can be assured that such dedication is a "hallmark" of security in the utilisation of public funding. - e) <u>Annual Governance Statement 2017/18</u> Members were given time to read the annual governance statement which was explained by the R.F.O. After discussion, the form was completed, approved and signed by the Chairman and Clerk.
- f) Annual Audit Return Accounting Statements 2017/18 The Clerk advised that the Annual Return Accounting Statements 2017/18 had been prepared for audit and signed by the Responsible Finance Officer on 14th May 2018. After discussion, the document was approved and signed by the Chairman of the meeting Cllr. M. Raymond.

<u>Update on Parish Council Vacancy</u> - A letter had been received from E.R.Y.C. Democratic Services confirming that a request to fill the vacancy by way of an election had not been received within the prescribed time period and the Parish Council may now fill the vacancy by co-option. A notice of co-option for one Parish Councillor will now be displayed on the Parish Council notice boards and website.

GDPR (General Data Protection Regulations) - Members had been provided with a briefing note from the Society of Local Council Clerks explaining the changes in law effective from 25th May 2018 which will affect the Parish Council. The Clerk is currently completing a data audit and obtaining the necessary procedural documents which are required for compliancy.

<u>ERNLLCA Membership (Benefits/Cost)</u> - The Clerk circulated information regarding the benefits of joining ERNLLCA (East Riding and Northern Lincolnshire Local Councils Association) and cost for the Parish Council to join. It was agreed further consideration and discussion is required at a future meeting.

<u>Blue Plaques</u> - The Chairman had been in communication with the owner of 4 Church Lane, about the possibility of installing a blue plaque on his Grade II listed property, to be paid for by the owner. All members were in agreement, additional plaques further enhance the Heritage Trail. Cllrs. M. Raymond and D. Robinson to discuss wording.
