## Minutes of the Parish Council Meeting held on Monday 10<sup>th</sup> June 2019 at 7.00pm

Minute 2652 - In response to the questions raised last month, the Chairman read out the reply from Andrew Jackson Solicitors LLP. Q. Has the information in the letter been circulated to church members? A. No, it has not been mentioned to all of the Electoral Roll but the information was discussed at the recent Annual Parochial Council Meeting. Q. Have local Funeral Directors been informed that the cemetery remains open? A. Drews have the Mill Lane application forms. Q. How many plots are available? A. 90 burial plots and 200 kerbstones available for purchase. In a burial plot you can bury up to two bodies and two sets of ashes, or four sets of ashes. In a kerbstone, you can bury up to two sets of ashes. Q. Information on costs. A. Information on various aspects relating to costs was reported. The Clerk was asked to write again to Andrew Jackson Solicitors LLP to suggest they inform a wider range of Funeral Directors. The Church could publish the information on their notice boards, but also need to consider that families of the deceased may well live outside of Kirk Ella.

Minute 2653 - It was advised that the first commuted sums payment from the development on Great Gutter Lane had been made. As part of the process of commuted sums, where large amounts of money are to be received, East Riding of Yorkshire Council will hold these monies until a parish wide consultation with relevant groups is held, this is to prioritise spend. The consultation will include the Parish Council, it is hoped this will commence during summer. Thoughts on projects including rough costings should be sent to Lea-Anne Wright at E.R.Y.C. Clerk to circulate information in the parish post.

<u>Minute 2655</u> - The Clerk had received an email from resident Mr. Beaumont, about the A164 Riplingham Road roundabout works which was read out to members.

7.50pm The Chairman suspended Standing Orders to allow Mr. Beaumont to speak to members about the content of his email.

<u>Letter of Consultation sent to residents about Wolfreton Garth snicket</u> - Unable to discuss in the absence of Cllr. E. Robinson.

Men in Sheds - An invitation had been received from the Anlaby with Anlaby Common Parish Council, to attend a meeting on Thursday 11<sup>th</sup> July at 7.00pm to learn about a possible joint venture with other local Councils.

Men in Sheds are community spaces for men to connect, chat and create. The activities are often similar to those of garden sheds but for groups of men to enjoy together. They help reduce loneliness and isolation but most importantly, they're fun. The social and health benefits of Men in Sheds reduce isolation, loneliness and empower local communities. There are over 400 Men's Sheds open today and an additional 100 or more in planning at any one time. That's around 10,000 or more Shedders, as we call the men, benefiting from regular social interactions, new and improved skills, and regular, active participation in activities they enjoy. The rate of growth of Men's Sheds is between six and nine a month.

Cllr. McMaster agreed to attend on behalf of the Parish Council.

#### 2669 Environment

General Maintenance Issues/Notice Board outside St Andrews Church, Kirk Ella - It was agreed the Clerk obtain a quote to refurbish the notice board outside the Church which is looking tired. An email sent by Cllr. E. Robinson was read out in her absence, advising that the area outside the Church steps had been tidied up by a resident. Work is required around the Church wall and the railings are rotten and in need of some urgent attention. A quote of £45 had been obtained to clear the land next to the school on West Ella Road and then spray with weedkiller, the possibility of planting wild flowers at this location was discussed, further discussion required when Cllr. E. Robinson is present. Cllr. Kaye spoke about the poor state of Kirk Ella village centre, particularly around the Church and grounds. Clerk to liaise with Cllr. Kaye and send a letter to the Church Office with details of our observations. Property owners are encouraged to keep their properties tidy. Clerk to contact E.R.Y.C. about the resurfacing of the Packman Lane footpaths.

The Clerk read out an email received from a resident about the poor state of Kirk Rise Green, and the area at the corner of Mill Lane and White Walk, which is looking neglected and overgrown. Resident to be informed that the grass on the areas where daffodils are present, does not get cut until at least six weeks after they have finished flowering. Email to be sent on to the E.R.Y.C.
